Project Summary: This item was continued from the May 23, 2016 Design Review Commission Meeting. This is an amendment to a Precise Plan of Design. On March 2015, the Design Review Commission approved an application for a proposal to construct a new mixed-use development with 159 residential condominium units and 16,549 square feet of commercial space. The proposed revisions include the elimination of 24 units spanning the Rubio Wash and relocates them throughout the development.

Staff Recommendation: Staff recommends that the Design Review Commission **APPROVE** Planning Case No. PL-14-041, subject to the recommended conditions of approval.
