

RESOLUTION NO. 12-20

**A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF SAN GABRIEL, CALIFORNIA ADOPTING THE SAN GABRIEL ENERGY ACTION
PLAN**

WHEREAS, the California State Legislature and Governor Arnold Schwarzenegger signed Assembly Bill 32, the Global Warming Solutions Act of 2006, which set a 2020 greenhouse gas emissions reduction goal; and

WHEREAS, the California Public Utilities Commission (CPUC) authorized Southern California Edison (SCE) to conduct strategic plan activities focused on energy efficiency to help implement the CPUC's California Long-Term Energy Efficiency Strategic Plan (CEESP), and

WHEREAS, SCE's strategic plan activities include funding and technical support of the San Gabriel Valley Council of Governments' (SGVCOG) Energy Efficiency Climate Action Plan (EECAP) and the development of an Energy Action Plan (EAP) with consultant PMC; and

WHEREAS, the City Council of San Gabriel considered the community-wide and municipal energy use reduction policies of the Energy Action Plan, and

WHEREAS, the City Council of San Gabriel recognizes the impact of energy use for residential, commercial, industrial and municipal buildings and facilities on the environment; and

WHEREAS, the City of San Gabriel has developed an Energy Action Plan for more sustainable energy usage so that the City and community can reduce electricity use and greenhouse gas emissions through the adoption and implementation of the Energy Action Plan, attached hereto.

WHEREAS, the City has found that the Energy Action Plan is categorically exempt from the California Environmental Quality Act under CEQA Guidelines Section 15308, Class 8, actions taken by regulatory agencies to assure the maintenance, restoration, enhancement, or protection of the environment where the regulatory process involves procedures for protection of the environment.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN GABRIEL DOES HEREBY ADOPT THE ENERGY ACTION PLAN.


