This report provides a summary of the Proposed Budget and Capital Improvement Plan (CIP) for Fiscal Year 2023-2024. City-wide operating revenues and expenditures total \$94,079,000 and \$91,616,000, respectively. The General Fund comprises revenues of \$51,585,000 and expenditures of \$50,185,000, for a positive net change in fund balance of \$1,400,000. The city-wide expenditure figures include \$16,701,000 for new capital improvement projects.

California Environmental Quality Act (CEQA) Determination: Not a Project as defined in Section 15378 of the State CEQA Guidelines.

Recommended Action:

Staff recommends that the City Council provide direction to staff on certain presented budget augmentations, the planned City special events for the upcoming fiscal year, and other items for the Fiscal Year 2023-2024 budget.
