

MINUTES OF AUGUST 25, 2020 SPECIAL MEETING OF THE SAN GABRIEL CITY COUNCIL

CALL TO ORDER

Chasity Jennings-Nuñez provided comments requesting the involvement of the Historic Preservation Commission before any decisions are made.

Donn Linton provided comments requesting consideration of the maintenance needs of the Wurlitzer pipe organ in the Mission Playhouse.

Discussion included solicitation of donors and fundraising suggestions, including GoFundMe; demand for theater venues; charging lower rates and expanding available days of use; diversity of performances; delay on restorative exterior painting due to the need to redesign the project pursuant to the recent nomination of the Playhouse to the National Register of Historic Places; status of grant funding for exterior painting; performing maintenance while the Playhouse is closed due to COVID-19 restrictions; Facility Fee fund balance and yearly revenue, including parking fees; long-term strategic planning; facilitating filming productions; detail on budget line items; staffing levels; clarification that under an emergency Executive Order the public comments submitted for the last meeting do not have

to be read aloud as they were included in the staff report for the item tonight; revenue to date; marketing outreach pursuant to COVID-19 guidelines; forming a 501(c)(3) to accept donations; referral networks; post-COVID planning; costsavings for other staff management models; mindset of subsidizing versus funding; value provided by the Playhouse to the City; pricing changes already in place; beneficial impact of Playhouse events on surrounding businesses; inclusion of relevant commission input; implementing a plan for the Playhouse during COVID-19 restrictions similar to the 10-Point Plan for Recovery, Resiliency, and Reinvestment, that could include organizational-structure, arts-development impact fees, reviewing existing contracts for fee appropriateness, fundraising, partnerships with local businesses for recognition, subscription options, grant opportunities, establishment of a 501(c)(3), expanding marketing and communication capacity, forming relationships with local news organizations, maintaining relationships with rental clients, filming opportunities, branding, virtual performances, advertising outside of the state and country, revenuegenerating activities during COVID, and parking lot repair; and a possible future advisory committee.

There was a consensus of the City Council to direct staff to pursue Scenario/Option 3 as listed in the staff report under which the Playhouse will remain open in a limited capacity through December 2020, allowing for livestreaming and filming events to continue; provide detailed line item information to Council in the future; and to move forward with full re-opening of the Playhouse once health orders allow.

City Manager Lazzaretto recognized Mission Playhouse Manager Elias Bourjeli for a great job managing the Playhouse, and expressed his gratitude to Community Services/Interim Mission Playhouse Director Perez for a job well-done directing two departments.

Mayor Menchaca gave a special thanks to Chief City Clerk Clark and her team for a good job responding to the many public comments for this item and for representing the City well; and to Mission Playhouse Manager Bourjeli and Community Services/Interim Mission Playhouse Director Perez for their patience, work, and great information.

3. ADJOURNMENT

The City Council meeting was adjourned at 9:47 P.M.
