Planning Case No. PL-15-078

Applicant/Architect: John Reischl (The Olson Company)

Project Summary: This is an application for a Precise Plan of Design. The proposed project includes demolition of six residential structures, which will be replaced with a residential community comprised of 31units. Parking for each unit will be at grade, within an enclosed garage, along with 10 guest parking spaces on-site as well as 7 driveway spaces. The property is designated as High Density Residential in the General Plan, and zoned R-3 (Arroyo Residential) in the Mission District Specific Plan area.

Staff Recommendation: Staff recommends that the Design Review Commission APPROVE Planning Case No. PL-15-078, subject to the recommended conditions of approval.
