This report was presented by Associate Planner De La Cruz regarding an application for a Master Sign Program for the San Gabriel Mission Playhouse. The historic Mission Playhouse is developing a new signage program that honors the history of the building, while providing for the routine needs of the facility. The proposed sign plan consists of a new monument sign, new blade signs, and

incidental site signage. The application also requests three variances for a Master Sign Program for the historic Mission Playhouse. These variances are to increase the height of a proposed monument sign, a request to allow the placement of a wall sign on a detached garden wall, and a request to

allow an increased number of projecting (or 'blade') signs for the property.

This report was reviewed and exempted for compliance with the California Environmental Quality Act (CEQA) per Guidelines Section 15301, Class 11 (Accessory Structures – On-premise Signs).

Staff recommends that the Design Review Commission approve Planning Case No. PL-12-008 (Master Sign Program), subject to the recommended conditions of approval and recommend approval of the requested variances to the Planning Commission.

Staff also recommends that the Planning Commission approve Planning Case No. PL-12-008 (Variances), subject to the recommended conditions of approval.

Applicant's Testimony

Anna Cross, Jonathan Salisbury and Steve Wilkinson from the San Gabriel Mission Playhouse, presented their report in support of the proposed sign. They also stressed the importance of branding and using a logo on the property, and stated that it unifies an organization from within by showing the public unity and professionalism.

Doug Joyce, from Onyx Architects, stated that this proposed sign would bring proper stewardship and vitality to the Playhouse.

Harry Baldwin, Vice President of the Historical Association, stated that the Association was in support of this sign program.

Commissioners' Discussion

The Commission commended everyone involved in this project including the architects and staff. However, they did express some concerns in regards to the LED lighting, how fast the sign pacing would be, vandalism to the sign and landscaping around the sign.

City Architect Dale Brown stated that the sign pacing will be set for vehicles but also paced for pedestrians. It will be a primarily black background with white text, similar to the marquee. Planning Manager Barrett reiterated that the pace of the sign would be slower and change approximately every 12 seconds in order to not be distracting to vehicles passing by.

Doug Joyce also confirmed that landscaping would be put in at the bottom of the sign to soften the look and help to reduce vandalism.

Commissioner Zawodny presented an idea to incorporate a camera to the sign that would capture children's faces as they walk up to it so that they can see themselves.

Design Review Commission Chair Nadolney made the motion to approve the master sign program and Planning Case PL-12-008 subject to the recommended conditions of approval and to recommend approval of the variances to the Planning Commission. Design Review Commission Design Review Commission Vice-Chair Nakaba seconded the motion.

3. 933 E. Las Tunas Drive

Planning Case No. PL-12-014 (Finding of Public Convenience or Necessity for License to Sell Beer, Wine and Distilled Spirits) **Applicant: Tawa Supermarkets (168 Market)**

This report was presented by City Planner Gallatin. The applicant has applied to the Department of Alcoholic Beverage Control (ABC) for a Class 21 license to sell beer, wine and distilled spirits for off-site consumption at a supermarket located in a shopping center at 927-937 E. Las Tunas Dr. (A previous license was issued to Albertson's for alcohol sales at this address.) The Planning Commission must consider whether to make a finding that a "public convenience or necessity" would be served by the issuance because the location is in a census tract with an "undue concentration" of that license class.

3. 933 E. Las Tunas Dr. Planning Case No. PL-12-014 (Finding of Public Convenience or Necessity for License to Sell Beer, Wine and Distilled Spirits)

This report was reviewed for compliance with the California Environmental Quality Act (CEQA) and is exempt per Guidelines Section 15301, Class 1 (Existing Facilities).

Staff recommends that the Planning Commission find that a public convenience of necessity would be served by the issuance of a Class 21 License to sell beer, wine and distilled spirits at 933 East Las Tunas and that the Planning Commission recommend to staff preferred procedures for handling similar requests in the future.

Applicant's Testimony

The applicant's representative, Brett Engstrom, stated that he had no comments at this time.

Commissioners' Discussion

The Commissioners had a couple of concerns with the CUP process in regards to making findings of "public convenience or necessity" for alcohol sales.

City Planner Gallatin explained that although the total fees are \$550 and approximately 2 hours went into creating the staff report for this project, the process is still worth it considering the competing public goods. He stated that it was important to (1) let the public know and (2) be business-friendly.

The Community Development Department recommends that the Planning Commission make the motion to find that a public convenience or necessity would be served by the issuance of a Class 21 License to sell beer, wine, and distilled spirits at 933 East Las Tunas and recommend to staff that similar requests be handled in the same fashion in the future.

Commissioner Zawodny made the motion to find that a public convenience or necessity exists for Planning Case PL-12-014. Vice-Chair Klawiter seconded the motion.
